5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - The described cables are to be supplied by NEXANS in compliance with the type and the requirements described in this certificate.

5.2 - This type of product is within the category IBV of Bureau Veritas Rule Note NR320.

5.3 - BV product certificate is required.

6. MARKING OF PRODUCT :

The cable shall be marked on the surface outer sheath, in a durable legible and visible manner, with the following information through the length of cable:

- 1) - Voltage grade.
- 2) - Cable symbol and temperature class.
- 3) - Number of conductors and conductor size.
- 4) - Applicable standard(s) to flame retardant and fire resistance if any
- 5) - Manufacturer's name or trade mark.
- 6) - Year of manufacture.

7. OTHERS :

7.1 - This approval is given on the understanding that the Society reserves the right to require check tests to be carried out on the cables at any time, and that NEXANS, will accept the responsibility for informing shipbuilders or their sub-contractors of the proper methods of use and general maintenance of the cables and the conditions of this approval.

7.2 - This certificate supersedes the Type Approval Certificate N° 12977/A0 BV issued on 26.06.2003 by the Society.
